The provision of the data is essential for the proper management of the contractual relationship; consequently, any refusal to provide it makes it impossible to process your enrolment.

PURPOSES OF THE PROCESSING: The personal data provided by you are collected by electronic means and processed, including with the aid of electronic tools, directly for your enrolment and for the administrative and organisational management of the course, including registration, the communication of information relating to the course, the management of payments and the issuing of certificates of attendance, as well as for statutory obligations, including tax and accounting obligations.

In no case will your data be disclosed or sold to third parties for their own purposes. The data required to create your account (First name, Surname and e-mail address) are processed on the Institute's Moodle platform, accessible at elearning.istitutounintess.it, installed on a virtual server supplied by Contabo GmbH (Munich, Germany), whose data centres are located in Germany and therefore within the European Economic Area: no transfer of data to third countries takes place. Contabo GmbH acts exclusively as Data Processor pursuant to Article 28 of Regulation (EU) No 679/2016, on the basis of a specific agreement, and does not process your data for its own purposes.

Within Istituto UNINTESS the data may be accessed only by specifically appointed persons working at the Registry Office. The data provided through the enrolment form will be retained until the final Certificate is obtained and, in any event, for no longer than 18 months. Data relating to proof of payment are retained for 10 years, so as to be able to respond to any accounting and tax audits. Personal data alone (First name, Surname, Date and place of birth, Course attended and marks obtained) will be retained for 15 years. No automated decision-making or profiling will ever be carried out.

Pursuant to Regulation (EU) No 679/2016, you have the right at any time to obtain from the Data Controller information on the processing of your data, on the methods and purposes thereof and on the logic applied to it, as well as:
